KNOW ALL MEN BY THESE PRESENTS, that H. S. Sellers

in consideration of One Dollar and correction of deed----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

W. Louis Williams , his heirs and assigns forever,

All that certain lot of land situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville at the southeastern corner of Chick Springs Road and Twin Lakes Avenue shown as Tract Nos. 1 and part of Tract 2 on a plat entitled "Property of Willis S. Hood" recorded in the RMC Office for Greenville County in Plat Book AAA at page 27 and being further described as follows:

BEGINNING at an iron pin on the eastern side of Chick Springs Road at the joint corner of Lot 43 and Tract 2 and running thence along the eastern side of Chick Springs Road, N. 23-16 E. 104.6 feet to an iron pin; thence N. 13-21 E. 5.4 feet to an iron pin at the corner of Tract No. 1; thence continuing along the eastern side of Chick Springs Road, N. 13-21 E. 37.3 feet to an iron pin; thence N. 6-06 E. 45 feet to an iron pin; thence along the curve of the intersection of Chick Springs Road and Twin Lakes Avenue, the chord of which is N. 48-50 E. 35.9 feet to an iron pin on the southern side of Twin Lakes Avenue; thence along Twin Lakes Avenue, S. 89-05 E. 270.9 feet to an iron pin on the edge of Stone Lake; thence along the edge of Stone Lake, the traverse of which is S. 30-54 W. 101.8 feet; thence S. 58-46 W. 61.7 feet; thence S. 14-01 W. 138.7 feet to an iron pin at the corner of property heretofore conveyed by deed recorded in Deed Book 695 at page 456; thence N. 76-22 W. 223.2 feet to the point of beginning.

Together with all rights and privileges in and to the bed and waters of Stone Lake as are accorded by law to a riparian owner including, without being limited to, the right and privilege as appurtenant to said lot, to go upon and use the waters of said lake for the purpose of engaging in normal aquatic sports such as boating, fishing and swimming and the further right to construct and maintain a dock or landing which does not extend farther than 15 feet from the water's edge, and is so located as not to interfere with the reasonable use of Stone Lake by any other riparian owner.

THIS deed is given to correct error in the description of a deed from grantor to grantee recorded in Deed Book 766 at page 277.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s') heirs, successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') heirs, successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s') heirs, successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
