KNOW ALL MEN BY THESE PRESENTS, that I, ^{OLLIE FARNSWORTH} E. L. Meperson, M. D.

in consideration of Three Thousand One Hundred Fifty and no/100 - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto William Brazeale, his heirs and assigns forever:

ALL that certain piece, parcel or lot of land, with the improvements thereon, known and designated as Lot No. 5 of Copeland Dale Sub-division, a plat of the same dated June, 1959, by Jones and Sutherland, Engineers, being recorded in Plat Book QQ at page 89 in the R. M. C. office for Greenville County, and having according to said plat the following courses and distances, to wit:

BEGINNING at an iron pin on the northeastern side of Hardale Lane, being the joint corner of Lots 4 and 5 and running thence S. 88 - 06 W. 16.7 feet to an iron pin; thence N. 80 - 44 W. 47 feet along a cord to an iron pin; thence N. 53 - 24 W. 47 feet along a cord to an iron pin; thence N. 46 - 50 W. 5 feet to an iron pin being the joint corner of lots 5 and 6; thence N. 32 - 14 E. 145.7 feet along the line of division of Lots 5 and 6 to an iron pin; thence S. 27 - 0 E. 10 feet to an iron pin; thence N. 88 - 10 E. 39.4 feet to an iron pin which is the joint rear corner of lots 4 and 5, thence S. 5 - 43 W. 152 feet along the line of division of Lots 4 and 5 to the point of the beginning.

BEING subject to the Restrictive Covenants applicable to Copeland Dale Sub-division, as noted and recorded in Deed Volume 630 at page 159 in the office of the R. M. C. for Greenville County. Further, the said lot is subject to a Drainage Easement of 2.5 feet each on the Line of Division of Lots 4 and 5 as shown on the plat heretofore mentioned. Further this lot is subject to Rights of way or Easements of Utilities now or to be recorded. Being a part of the property conveyed to the Grantor as noted in Deed Volume 598, page 291.
