KNOW ALL MEN BY THESE PRESENTS, that I, B. H. TRAMMELL

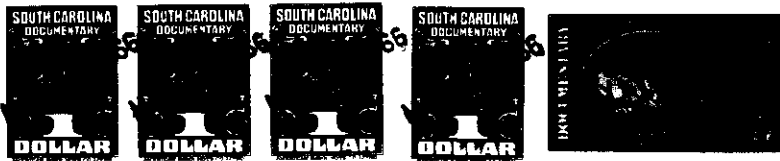
in consideration of One Thousand Seven Hundred Fifty and No/100---(\$1,750.00)----- Dollars,

All that piece, parcel or lot of land located in the County of Greenville, South Carolina,
situate, lying and being on the Western side of Razor Drive and being known and designated
as Lot No. 2 on a plat entitled "Property of B. H. Trammell", dated February 7, 1958
by J. C. Hill which is to be recorded, and having according to said plat the following metes
and bounds, to-wit:

BEGINNING at a point on Razor Drive, joint front corner of Lots 1 and 2 according to said
plat and running thence along the line of Lots 1 and 2 S. 19-22 E. 175.1 feet to a point;
thence running S. 71-17 E. 58.8 feet to a point; thence running N. 20 E. 175.2 feet to a
point on Razor Drive; thence running along Razor Drive N. 71-17 W. 63.75 feet to the point
of beginning.
