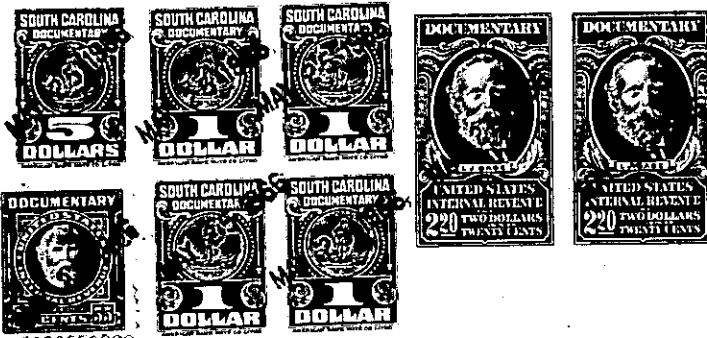
in consideration of FOUR THOUSAND FIVE HUNDRED AND NO/100ths ----- Dollars,
