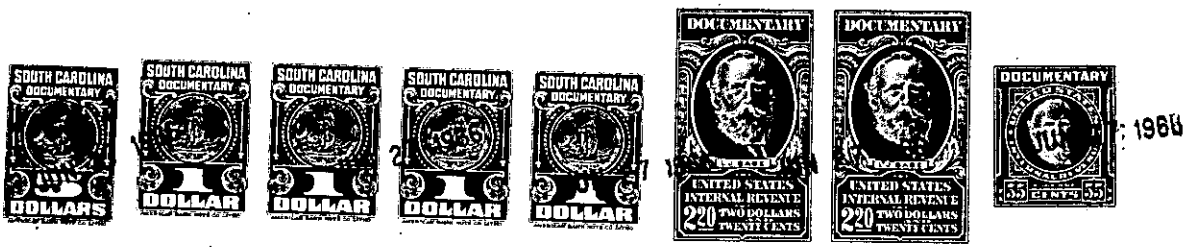
KNOW ALL MEN BY THESE PRESENTS, that I, John Ellison Brown, of Greenville County
