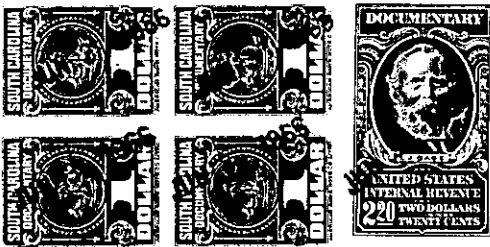
KNOW ALL MEN BY THESE PRESENTS, that I, James A. Boling
