A. L. Bolt and Frances G. Bolt, their heirs and assigns, forever:

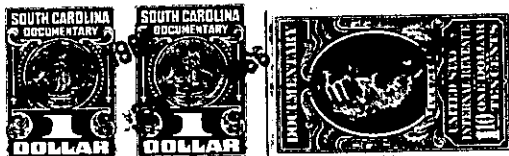
ALL that piece, parcel or lot of land in the State and County aforesaid,
