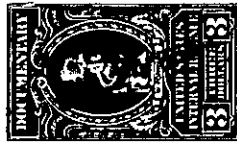
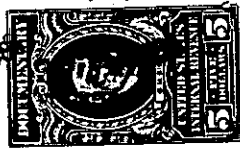
KNOW ALL MEN BY THESE PRESENTS, that We, Arlie Etherton and Louise T. Etherton
