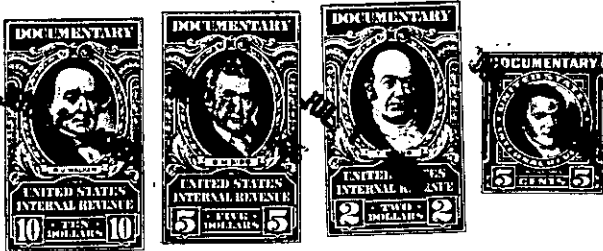
KNOW ALL MEN BY THESE PRESENTS, that I, J. P. Medlock, of Greenville County, S. C. 1966

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Wilbur L. Dyer and Brandon R. Dyer, their heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 8 of a subdivision known as Colonial Hills, Section No. 3, as shown on plat thereof prepared by Piedmont Engineers & Architects, dated May 7, 1965, recorded in the R. M. C. Office for Greenville County in Plat Book BBB, at Page 91, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Creighton Street at the joint front corner of Lots 7 and 8 and running thence with the joint line of said lots, N. 80-15 W. 150 feet to an iron pin, joint rear corner of Lots 7 and 8; thence with the rear line of Lot 8, S. 9-45 W. 100 feet to an iron pin at the joint rear corner of Lots 8 and 9; thence with the joint line of said lots, S. 80-15 E. 150 feet to an iron pin on the western side of said Creighton Street, joint front corner of Lots 8 and 9; thence with the western side of said Creighton Street, N. 9-45 E. 100 feet to the point of beginning; being the same conveyed to me by Williams Land Co. by deed dated July 13, 1965, and recorded in the R. M. C. Office for Greenville County in Deed Vol. , at Page
