the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto James Barnett Taylor and Janet Bates Taylor, their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the southwestern side of Woodmont Circle and being known and designated as Lot No. 22, Block D of Brookforest Subdivision, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "BB", at Pages 40 and 41, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Woodmont Circle at the joint front corner of Lots Nos. 22 and 23 and running thence along the southwestern side of said Circle S. 34-18 E. 70 feet to an iron pin; thence along the joint line of Lots Nos. 21 and 22 S. 55-42 W. 205.3 feet to a point in the center of branch; thence along the center of the branch as the line in a northwesterly direction to the joint rear corner of Lots Nos. 22 and 23, the traverse line being S. 34-18 E. 60 feet; thence along the joint line of Lots Nos. 22 and 23 N. 52-45 E. 216.5 feet to an iron pin, the point of beginning.
