Highway 276, the joint front corner of Lots 18 and 19, and running thence with the joint line of said lots, N. 49-32 E. 150 feet to an iron pin; thence along the line of Lot 20, S. 40-28 E. 100 feet to an iron pin at the joint rear corner of Lots 18 and 17; thence with the joint line of said lots, S. 49-32 W. 150 feet to an iron pin on the Eastern edge of the above named right-of-way; thence with the side of said right-of-way, N. 40-28 W. 100 feet to an iron pin at the point of beginning. This is a portion of the property conveyed to the grantor by deed recorded in the R.M.C. Office for Greenville County in Deed Book 731, at page 529.

Grantee, his heirs or assigns, shall not use said lot for any construction, except for the construction of a single family residence, which shall contain not less than 1400 square feet of living space(such construction shall be of brick or brick veneer finish), exclusive of carports, garages and porches; 2. No business or commercial enterprises shall be carried on on said lot and no animals, except ordinary domesticated housepets, shall be maintained on said lot. 3. The above restrictions shall not prohibit the grantee from constructing on said lot a private swimming pool.
