the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Stanley B. Duffies, II and Dorothea F. Duffies, their heirs and assigns forever:

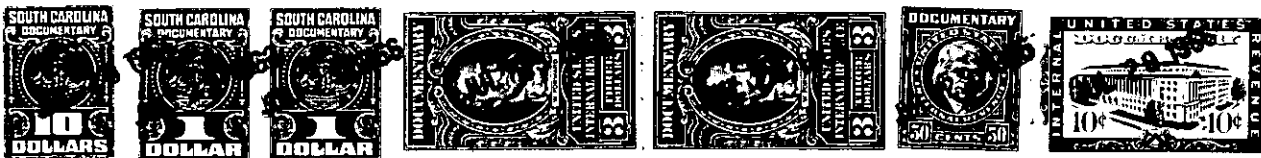
All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, being known and designated as Lot No. 34 of a subdivision of the property of the grantors as shown on a preliminary plat thereof prepared by Piedmont Engineers and Architects, and having, according to a plat entitled "Property of Dorothea F. Duffies & Stanley B. Duffies" prepared by Piedmont Engineers and Architects June 8, 1966, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern edge of Graystone Road, the joint front corner of Lots Nos. 33 and 34, and running thence along the joint line of said lots, S. 79-54 E. 385.47 feet to an iron pin; thence S. 15-49 W. 215.0 feet to an iron pin; thence N. 75-56 W. 319.0 feet to an iron pin on the eastern edge of Graystone Road; thence along the eastern edge of Graystone Road, following the curvature thereof, the chord of which is N. 3-15 W. 197.25 feet, to the beginning corner.

This conveyance is subject to utilities easements of record and is also subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 690, Page 531 as amended by subsequent restrictions recorded in Deed Vol. 758, at Page 116.

The above referred to plat entitled "Property of Dorothea F. Duffies & Stanley B. Duffies" is recorded in the R. M. C. Office for Greenville County in Plat Book MMM at Page 158.
