release unto Robert L. Parris and Martha P. Parris, their heirs and assigns forever.

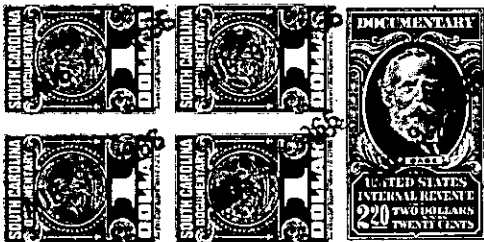
All that piece, parcel or lot of land situate, lying and being in the County of
Greenville, State of South Carolina, on the southwestern side of Pinnacle Drive
and being known and designated as Lot No. 23, Section C, of Green Forest as
shown on plat thereof recorded in the R. M. C. Office for Greenville County in
Plat Book "KK", at Page 87, and having, according to said plat, the following
metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Pinnacle Drive at the
joint front corner of Lots Nos. 22 and 23 and running thence along the joint line of
said lots S. 51-36 W. 216.2 feet to a point; thence S. 50-07 E. 132 feet to an iron
pin; thence along the joint line of Lots Nos. 23 and 24 N. 35-44 E. 198.8 feet to
an iron pin; thence along the southwestern side of Pinnacle Drive, as follows:
