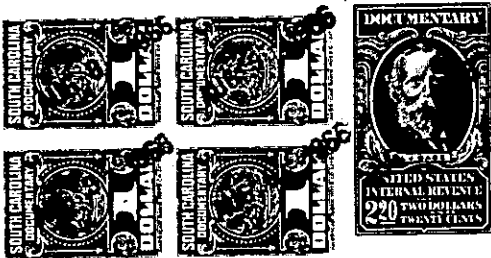
L. Alfred Vaughn, his heirs or assigns forever:
