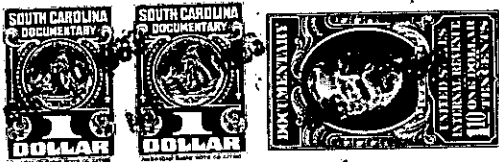
KNOW ALL MEN BY THESE PRESENTS, that I, Emily Hunt

All that piece, parcel or lot of land in Greenville Township, Greenville County, State aforesaid about four miles from the Greenville County Court House on the New Easley Bridge Road and known and designated as Lot No. 3, as shown on a plat of the property of R. J. Sentell, made by Dalton and Neves, Engineers, in June, 1935 and being more particularly described as follows:
