in consideration of the sum of Ten and no/100 (\$10.00) Dollars and other valuable consideration

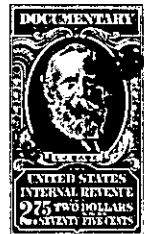

All that piece, parcel or lot of land situate, lying and being on the Northerly side of Pelham Road near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 31 and shown on a plat entitled "Subdivision for Rosamond Estate", prepared by Piedmont Engineers & Architects, dated February 11, 1965, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book JJJ at page 29, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northerly side of Pelham Road at the joint front corner of Lots Nos. 30 and 31, and running thence with the line of Lot. No. 30 N. 7-54 W. 270 feet to an iron pin in the line of Lot No. 28; thence with the line of Lots Nos. 28 and 29 S. 82-06 W. 200 feet to an iron pin at the joint rear corner of Lots Nos. 31 and 32; thence with the line of Lot No. 32 S. 7-54 E. 270 feet to an iron pin on the Northerly side of Pelham Road; thence with the Northerly side of Pelham Road N. 82-06 E. 200 feet to the point of beginning.

The premises hereinabove described are conveyed subject to certain restrictions and protective covenants recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 772 at page 237 and to such easements and rights of way, if any, which affect or may affect the same.
