THIS is a Duplicate Deed given to replace one which was possibly not recorded, having been lost or misplaced.



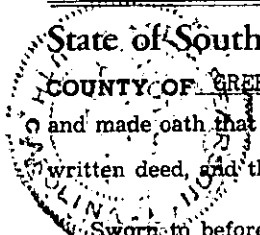
TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.
