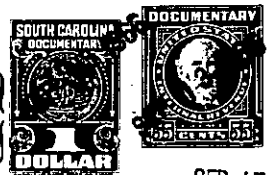

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Norman Mayfield and his heirs and assigns forever.

All that piece, parcel or lot of land in Chick Springs Township, County of Greenville, State of South Carolina, located in the City Limits of Greer, S.C., and being shown as all of lot number THIRTY FIVE (35) on a plat of property entitled "Maple Heights" made for Lee. G. Smith Estate by H.S. Brockman, surveyor, dated Aug. 29, 1958, which plat is recorded in plat book MM page 31, Greenville County R.M.C. Office and has the following metes and bounds, according to said plat, to wit:
