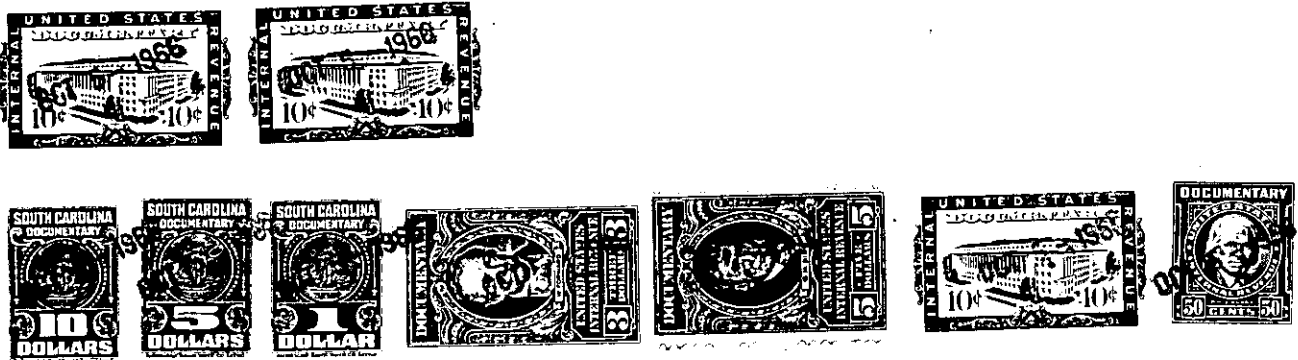
KNOW ALL MEN BY THESE PRESENTS, that Botany Woods, Inc.
