the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Willie Lee Williams, his Heirs and Assigns,

All that piece, parcel or lot of land in the County of Greenville, State of South Carolina in Paris Mountain Township, Near Motor Boat Club Road, and being more particularly described as Lot Number Two (2), according to a plat of the property of Ed Robinson's Estate by Carolina Engineering & Surveying Co., September 27, 1966, and having the following metes and bounds, to wit:

Beginning at an iron pin on the Eastern edge of a proposed road at the joint front corner of Lots Number One (1) and Two (2) and running thence along the joint line of said Lots, S. 82 - 200 feet to an iron pin; thence N. 82.0 W. 100.0 feet to an iron pin on the Eastern Side of a proposed road; thence along the line of said proposed road, N. 8.0 E. to an iron pin, on the line of Mastors property, said pin, being located 21.4 feet from the S/W corner of the Mastors property, and running thence along the line of the Mastors property, S. 82.0 E. 200.0 Feet to an iron pin; thence S. 8.00 W., 100 Feet to an iron pin; thence N. 82.0 W. 200 Feet to an iron pin; thence N. 8.0 E. 100.0 feet to an iron pin, the beginning corner.
