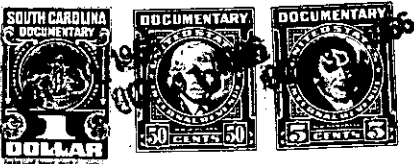

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Alonzo Calwile his Heirs and Assigns forever:

All that piece, parcel or Lot of land lying, being and situate in the County and State aforesaid, known and designated as Lot No. 10 in Block A on a Plat of Friendship Heights 1 mile Northeast of the Town of Fountain Inn, prepared by W. N. Willis, Engineers, May 30, 1960, and having according to said Plat, the following courses and distances, to-wit: Beginning at an iron pin in the Northwestern edge of Friendly Street, joint corner with Lot No. 11 on said Street, and running thence with the Northwestern edge of said Street S. 29-00 W. 80 feet to an iron pin, joint front corner with Lot No. 9 on said Street; thence with the joint line of said Lot No. 9 N. 16-00 W. 180 feet to an iron pin, back joint corner with said Lot No. 9; N. 29-00 E. 80 feet to an iron pin, back joint corner with Lot No. 11; thence with the joint line of said Lot No. 11. S. 16-00 E. 180 feet to an iron pin on Friendly Street, the point of beginning and being bounded by said Friendly Street and Lots Nos. 9 & 11 in Block A as shown on said Plat. The within conveyed lot being a small portion of the land conveyed to the Grantor by deed of Real Estate Fund, Inc., June 10, 1960, said deed of record in the R. M. C.
