Campbell, dated August 30, 1965, and recorded in the R. M. C. Office for Greenville County in plat Book "JJJ" at page 71; and having, according to said plat, the following metes and bounds:

BEGINNING AT an iron pin on the Northeast side of East Seven Oaks Drive at the joint front corners of Lots 7 and 8 and running along said lot lines N 37-22 E. 157.3 feet to an iron pin; thence turning and running along the rear lot line of Lot 7 S 47-19 E. 120 feet to an iron pin at the joint rear corners of Lots 7 and 6; thence turning and running along said lot lines S 35-11 W. 144.3 feet to an iron pin on East Seven Oaks Drive; thence turning and running along East Seven Oaks Drive N 54-49 W. 32.4 feet to an iron pin; thence continuing along East Seven Oaks Drive N 53-06 W. 92.6 feet to the point of beginning.

This property is subject to easements and restrictions shown on said plat and to restrictive covenants recorded in the R. M. C. Office for Greenville County in Vol. 784 at page 329.
