HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Mamie D. Robinson and Doyle L. Robinson

ALL those two certain pieces, parcels or lots of land situate on the Northwestern side of South Carolina Highway #20, Grove Townshi Greenville County, State of South Carolina, containing 8.76 acres and 1.68 acres, respectively, and having according to a plat made by John C. Smith, recorded in the R. M. C. Office for Greenville County in Book NNN, page 119, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northwestern side of South Carolina Highway No. 20, at the corner of property now or formerly owned by Henry C. Smith and running thence with the Northwestern side of Highway No. 20, 634.3 feet to an iron pin on county road; thence with center of said county road as the line N 34-45 W 154.8 feet to pin; thence continuing N 10-3.5 W 225 feet to pin; thence S 85-08 W 1088.9 feet to a pin; thence N 13-57 W 302 feet to iron pin; thence N 88-37 E 1553.6 feet to point of beginning

The purchase price of the above described property is \$7500.00 and the sum of \$2300.00 was paid by the purchasers to the Master and the balance of \$5200.00 was paid by the purchasers executing a note and mortgage to Betty J. Allen as General Guardian for the four minor respondents, Angela J. Allen, John M. Allen, Jerry L. Allen and Jimmy V. Allen.
