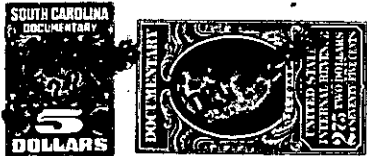
in consideration of Two Thousand Forty and No/100 (\$2,040.00)-----Dollars,
