to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto SALLY R. PARKER AND RONNIE

J. PARKER, their heirs and assigns forever,  
All that certain piece, parcel or lot of land, situate, lying and being, on the Eastern side of Satterfield Road in the County of Greenville, State of South Carolina, containing one (1) acres, more or less, and shown more particularly on a plat of the Property of Ronnie J. and Sally R. Parker, made by C. O. Riddle, January 17, 1967, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book NNN at Page 161, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Satterfield Road, at the joint corner of property hereby conveyed and other property of grantor, which iron pin is approximately 215 feet in a southerly direction from the intersection of Old Georgia Road and Satterfield Road, and running thence along the line of property of the grantor, S. 83-14 E. 200 feet to an iron pin; thence continuing along the line of property owned by the grantor, S. 6-46 W. 218 feet to an iron pin; thence continuing along the line of other property of grantor, N. 83-14 W. 200 feet to an iron pin on the eastern side of Satterfield Road; thence along the eastern side of Satterfield Road, N. 6-46 E. 218 feet to the point of beginning, together with all the grantor's right, title and interest in and to that certain strip of land averaging approximately 24 feet in width and having a distance of 218 feet, included within the right of way of Satterfield Road; this being a portion of the property heretofore conveyed unto the grantor by H. C. Hamby by Deed dated July, 1947, and recorded in the R. M. C. Office for Greenville County in Deed Book 315, at page 2.
