Notice of such revocation shall be deemed complete to all concerned upon the filing or recording of a written revocation, signed by me, in the office of the County recorder, or if there be no such officer, then the officer authorized to record deeds, in Greenville County, State of South Carolina.

GIVING AND GRANTING unto my said attorney full power and authority to do and perform all and every act, deed, matter, and thing whatsoever in and about my estate, property, and affairs as fully and effectually to all intents and purposes as I might or could do in my own proper person, if personally present, the herein specially enumerated powers being in aid and exemplification of the full, complete and general power herein granted and not in limitation or definition thereof; and hereby ratifying all that my said attorney, EVELYN D.
