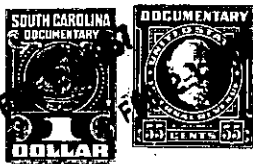

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents, do grant, bargain, sell and release

unto Herbert Keith Crawley and Claudette McCraw Crawley, their heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the south side of Beck Avenue and being known and designated as Lot No. 253 on plat of Augusta Road Ranches recorded in the R. M. C. Office for Greenville County in Plat Book "M", at Page 47, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Beck Avenue at the joint front corner of Lots Nos. 252 and 253 and running thence along the joint line of said lots S. 0-13 E. 140 feet to an iron pin; thence N. 89-47 E. 60 feet to an iron pin; thence along the joint line of Lots Nos. 253 and 254 N. 0-13 W. 140 feet to and iron pin on the south side of Beck Avenue; thence along the south side of said Avenue S. 89-47 W. 60 feet to the point of beginning.

The above is the same property conveyed to the grantor by deed recorded in Deed Book 741, at Page 527.

As part of the consideration of this conveyance the grantees assume and agree to pay the balance due on the mortgage over the above property to General Mortgage Co. in the original amount of \$10,500.00 on July 9, 1954 and recorded in Mortgage Book 601, Page 453.
