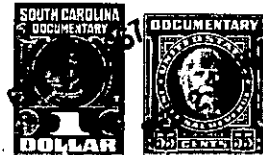

Know All Men by These Presents That L. L. Haulter and Faye J. Haulter

of said County and State, for and in consideration of the premises, and of the sum of Three Hundred and Ten and No/100 (\$310.00) ----- Dollars

to US in hand paid by THE CITY OF GREENVILLE, SOUTH CAROLINA, the receipt whereof is hereby acknowledged, do hereby grant unto the said THE CITY OF GREENVILLE, SOUTH CAROLINA, its successors and assigns, the right, privileges and easement to go in and upon that tract of land, situated in Bates Township, in the said County and State, bounded by lands of Kenneth Garland on the West; Farmview Lane on the North; Frances J. Hagan on the East; and P. M. Johnson on the South; the land affected by this deed is more particularly described and shown by deed to the Grantor herein recorded in the RMC Office for Greenville County in deed Book 480 at page 477. The right of way conveyed by this deed is more particularly described and shown by plat entitled "Water Line Right of Way L. L. & Faye J. Haulter to City of Greenville, S.C." attached hereto and made a part of this conveyance.



and to construct and maintain in, upon and through said premises, in a proper manner, a pipe line or lines, air vents, blow off connections, manholes and other necessary apparatus incident thereto, using the necessary appliances and machinery for such work for the purpose of conveying water through the premises above described, together with the right at all times to enter upon said premises for the purpose of inspecting said line or lines and making necessary repairs and alterations thereon, together with the right to cut away and keep clear of said pipe line or lines all trees and other obstructions that may in any way endanger or interfere with the proper operation of or access to the same.

It is understood and agreed that the right of way to be used under this contract during construction is to be Eighty feet in width throughout the entire length which is approximately 89 feet, and the damage, which THE CITY OF GREENVILLE, SOUTH CAROLINA, is to be liable for during construction, is to be confined to this strip and nothing beyond. The location of the pipe line or lines, when laid, will determine the definite location of the right of way. The center of the pipe line or lines shall be accepted as lying twenty-five feet from the Southern boundary line of this right of way. The remaining fifty feet of said right of way

during construction shall lie North of the center of said pipe line or lines and the entire right of way may be used for the purpose of installing the pipe line or lines. The location of said pipe line or lines is to be approximately along the line as now located and staked out by the engineers, subject to a variation of not exceeding five feet either way. The permanent right of way, after the pipe line or lines are installed, shall be Eighty feet in width measuring as shown by said attached Plat and no obstruction shall be hereafter placed on said Eighty foot right-of-way. If in laying the pipe line or lines, it is necessary to cut any timber from the right of way, such timber shall be placed at the edge of the right of way on the land of the undersigned grantor and shall be the property of the undersigned grantor.

It is further understood that the owner is to have the right to cultivate and use this right of way strip of land provided such use thereof shall not interfere with the proper maintenance and free access to the pipe line or lines to be installed under this agreement. No buildings or other structures shall be placed on said right of way ~~xxxxxx~~

The payment above specified covers compensation for the easement or right of way, and also covers all claims for damages, including crops growing on the right of way during the year 19 67, along said right of way resulting from construction of the pipe line or lines to be laid.

It is further agreed that in case of future damages to property or crop, due from an accident on the pipe line that THE CITY OF GREENVILLE shall pay all damages.

The undersigned agrees to release and give to THE CITY OF GREENVILLE, SOUTH CAROLINA, actual physical possession of the premises above described not later than the 1st day of March, 19 67.
