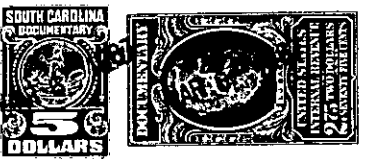
KNOW ALL MEN BY THESE PRESENTS, that I, Thomas Beauford Dorr, OLLIE FARRINGTON R.M.C.
