KNOW ALL MEN BY THESE PRESENTS, that I, J. P. Medlock, of Greenville County,

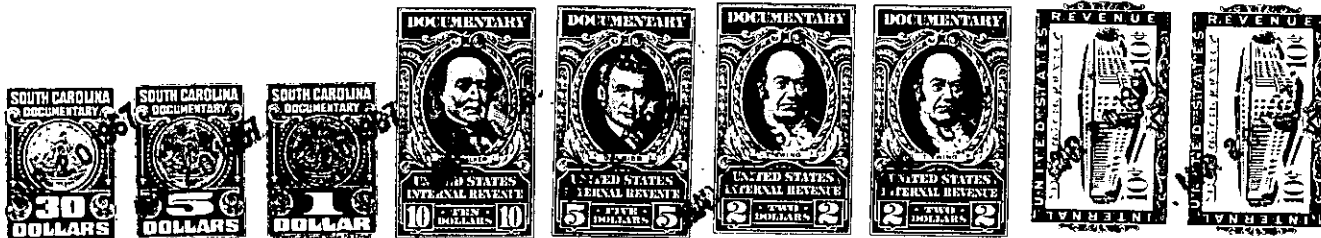
in consideration of Seventeen Thousand, Nine Hundred Fifty and No/100----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Milton L. Cathey and Lenora C. Cathey, their heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 18 of a subdivision known as Colonial Hills, Section 3, as shown on a plat thereof being recorded in the R. M. C. Office for Greenville County in Plat Book BBB, at Page 91, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Creighton Street, joint front corner of Lots Nos. 17 and 18, and running thence with the joint line of said lots, S. 80-15 E. 160 feet to an iron pin in the line of Lot No. 142; thence with the side line of Lot No. 142, N. 9-45 E. 125.9 feet to an iron pin on the southern side of Ardmore Drive; thence with Ardmore Drive, N. 86-33 W. 43.9 feet to an iron pin; thence continuing with said drive, N. 80-47 W. 91.5 feet to an iron pin; thence continuing with Ardmore Drive as it intersects with Creighton Street, following the curvature thereof, the chord of which is S. 54-29 W. 35.6 feet, to an iron pin on the eastern side of Creighton Street; thence with Creighton Street, S. 9-45 W. 95 feet to the beginning corner.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat (s), or on the premises.
