All that certain piece, parcel or lot of land, together with improvements thereon, situate, lying and being on the southwestern side of Galax Drive, known and designated as Lot 26, Section 2, Richmond Hills Subdivision, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book JJJ at Page 81 and having, according to said plat, the following metes and bounds, to-wit:
