KNOW ALL MEN BY THESE PRESENTS, that we, Norman K. Wright and Elliotte D. Wright,

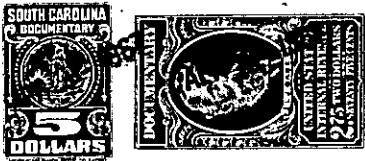
in consideration of Two Thousand, Four Hundred Forty-Five and 33/100-----(\$2,445.33)----Dollars,

C. Adams, Engineer, November, 1955 and recorded in the R. M. C.
