

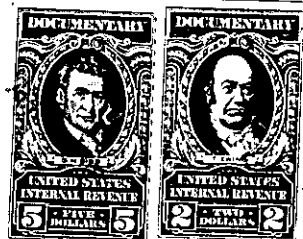

KNOW ALL MEN BY THESE PRESENTS, that I, J. J. Kaufmann, Jr., as Trustee

in consideration of Eight Thousand, Five Hundred and No/100 - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

VIRGINIA P. TAYLOR, her heirs and assigns forever,

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, known and designated as Lot No. 5 on plat made by Dalton & Neves, Engrs. June 1928 of that subdivision known as East Lake on the Old Spartanburg Road and having the following metes and bounds:

BEGINNING at an iron pin on the East side of the Spartanburg Road at the corner of Lots 4 and 5, this being 70.1 feet from the intersection of Spartanburg Road and West Circle and running thence along Spartanburg Road, N. 56-00 East 50.1 feet to an iron pin, the corner of Lots 5 and 6; thence along line of Lot 6, S. 37-20 West 168.8 feet to an iron pin; thence S. 52-40 W. 50 feet to an iron pin; thence N. 37-20 East 171.7 feet to the beginning corner and being the same property conveyed to W. O. Jones by deed recorded in Deed Book 148, at page 19.

ALSO: ALL that piece, parcel or lot of land in the County and State aforesaid on the Eastside of Spartanburg Road and being known and designated as a 10.1 foot strip off the northern part of Lot No. 4 as shown on plat of East Lake, recorded in Plat Book G, page 229, RMC Office for Greenville County.

BEGINNING at a point 60 feet from the northeast intersection of Spartanburg Road and West Circle Street (said point being in the line of Lot 4); thence running in a line parallel with said West Circle Street in a southeasterly direction 171.7 feet to an iron pin in line of Lot 46; thence with line of Lot 46, 10.1 feet to the corner of Lot No. 5; thence with the line of Lot No. 5 in a northwesterly direction 171.7 feet to an iron pin on the East side of Spartanburg Road; thence with said Spartanburg Road in a southwesterly direction 10.1 feet to the point of beginning.

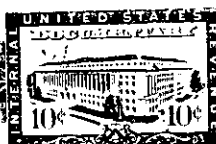
