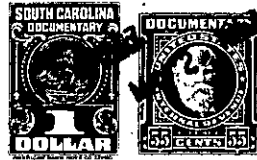

All that piece, parcel or tract of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot 87 of Peace Haven, Section No. 1, as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book VV at page 83 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Elm Street at the joint front corner of Lots 85 and 87 and running thence along the line of Lot 85, S. 64-57 W. 200 feet to an iron pin at the joint rear corner of Lots 85, 86, 87 and 88; thence along the line of Lot 88, N. 21-24 W. 116 feet to an iron pin on right-of-way of Duke Power Company; thence along said right-of-way, N. 59-16 E. 202.3 feet to an iron pin on Elm Street; thence along Elm Street, S. 21-24 E. 135.4 feet to the beginning corner.
