All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the north side of Fifth Street, in Section No. 6 of Judson Mills Village, near the city of Greenville, in the county of Greenville, state of South Carolina, being known and designated as Lot No. 107 on a plat thereof recorded in the RMC Office for Greenville County, S. C. in plat book K at pages 106 and 107, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Fifth Street, joint front corner of Lots No. 107 and 108, and running thence with the line of Lot No. 108, N. 1-37 W. 136.7 feet to an iron pin in line of Lot No. 25; thence with the line of lot No. 25, S. 88-23 W. 71 feet to an iron pin corner of lot No. 106; thence with the line of said lot S. 1-37 E. 135.5 feet to an iron pin on the north side of Fifth Street; thence with the north side of Fifth Street N. 89-25 E. 71 feet to the beginning corner.
