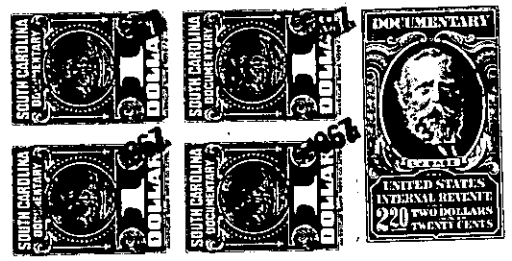
KNOW ALL MEN BY THESE PRESENTS, that **WILLIAMS BUILDERS, INC.**
