Green; thence along the line of said Edward J. Green property, S. 41-36 E. 62.9 feet to an iron pin in the line of property of Edward J. Green; thence N. 66-00 E. 1488.1 feet to an iron pin; thence around a curve, the chord of which is S. 72-27 E. 30 feet to a point on the Southwest side of the Woodruff Road, which point is in the right of way of said road; thence along the right of way of said Woodruff Road, N. 30-55 W. 57.05 feet to an iron pin; thence continuing along said right of way, N. 47-02 W. 44.85 feet to the beginning corner.
