

(1) All those certain lots or parcels of land, with improvements thereon, in Greenville Township, Greenville County, State of South Carolina, known and designated as Lots 33, 34, and 35, of Tract No. 2, of the Estate of John B. Marshall, as shown by plat recorded in the RMC Office for Greenville County in Plat Book J at Page 132 and 133, and according to said plat more particularly described as follows:

BEGINNING at an iron pin at the southwestern intersection of White Horse Road and a fifty foot unnamed street and running thence along the western side of White Horse Road S. 23-45 E. 235 feet to iron pin on alley shown on said plat; thence along the northern side of said alley N. 86-45 W. 306 feet to iron pin; thence N. 3-15 E 210 feet to iron pin on the south side of said fifty foot unnamed street; thence along the south side of said street S. 86-45 E. 200 feet to the point of beginning.

This is the same property conveyed to W. H. Brown, deceased, by deed of the First National Bank, et al, dated June 1, 1942, and recorded in the RMC Office for Greenville County, S. C. in Deed Book 245, Page 87.

(2) All that piece, parcel and tract of land lying and being in Bates Township, Greenville County, South Carolina, adjoining lands now or formerly belonging to Jack McCall and Irvin Philpot and John McDanele. Said property begins on the White Horse Road at fork of a Settlement Road and runs thence with White Horse Road N. 9 W 4.88 chains to a post oak stump; thence N. 83 W. 5.14 chains to iron pin; thence S. 27 E. 7.33 chains to center of a Settlement Road; thence N. 65 E 2.43 chains to beginning, and containing 2.16 acres, more or less and being the same land conveyed to Fred T. Couch and Dennis D. Couch by Fred and Grace E. Atkinson by deed dated January 21, 1956, recorded in Deed Book 543, Page 522, RMC Office, Greenville County.

(3) All that piece, parcel and tract of land lying and being in Bates Township, Greenville County, South Carolina, located about one mile west from Renfrew Mills, and being a part of the tract of land conveyed to Fred T. Couch and Dennis D. Couch by deed of Charles W. and Leila Mae Loftis by deed dated February 7, 1956, recorded in Deed Book 545, Page 2, being known as lot Number 1 as shown on plat of I. H. Philpot property as made by H. L. Dunahoo, Surveyor, dated December 6th and 7th, 1949, recorded in Plat Book T, Page 427. Said property begins at point on west side of the Old White Horse Road; thence with west edge of said road 275 feet to point on said road; thence S. 76-30 E. 341 feet to point on eastern side of S. C. Highway No. 250; thence with the eastern edge of said highway 176 feet to beginning.

Tracts 2 and 3 hereinabove described are the same property conveyed to W. H. Brown, deceased, by deed of Mary Gladys Adams, dated June 22, 1957, and recorded in the RMC Office for Greenville County, S. C. in Deed Book 579 at Page 107.
