All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville township. School districk 6. * E. being known and designated as lot, No.15 of a subdivision of the property of James H. Campbell, and Talmer Cordell as shown on plat thereof made by Dalton and Neves in March 1951, and recorded in the R. M. C. Office for Greenville County, in Book 743 page 237 and having the following metes and bounds to wit;
