All that certain piece, parcel or tract of land, situate, lying and being on the southwest side of Rushmore Drive in the County of Greenville, State of South Carolina, said tract being a strip ten (10) feet in width at its widest point, beginning at the intersection of Rushmore Drive and Wade Hampton Boulevard and extending along Rushmore Drive a distance of 1,000 feet, more or less, and being shown and designated as Addition No. 1 to street right-of-way on plat entitled "Street for Wildaire Estate IV" recorded in the Greenville County R. M. C. Office in Plat Book PPP at page 113.

Also, all that certain piece, parcel or tract of land, situate, lying and being on the northeastern side of Rushmore Drive in the County of Greenville, State of South Carolina, said tract being a strip ten (10) feet in width at its widest point, beginning at the intersection of Edwards Road and Rushmore Drive and extending along Rushmore Drive a distance of 600 feet, more or less, and being shown and designated as Addition No. 2 to street right-of-way on plat entitled "Street for Wildaire Estate IV" recorded in the Greenville County R. M. C. Office in Plat Book PPP at page 113.

It is the intention of the grantor by this conveyance to provide an additional right-of-way so as to increase the width of the right-of-way for Rushmore Drive from 50 feet to 60 feet throughout.
