

continuing with the line of said Old Plantation Road as it crosses Haywood Road N. 22-52 E. 313.5 feet to a pin in said Old Plantation Road; thence continuing with the line of said Road N. 12-52 E. 286 feet to a pin in said Road; thence continuing with the line of said Road in a north-westerly direction 682 feet to a pin in said road, corner of Laurel Creek Cemetery; thence with the line of said property N. 67-45 W. 263 feet to an iron pin; thence continuing with the line of said property N. 15-18 E. 222.4 feet to an iron pin on the southeast side of property heretofore conveyed by the grantor to the County of Greenville for construction of a county road (Transit Drive); thence continuing along line of said property N. 68-49 W. 93.2 feet to a point on the southeast side of Airport Road Extension (formerly called Rickenbaker Road); thence with the southeast side of said road S. 25-12 W. 71 feet to an iron pin; thence S. 32-47 W. 100 feet to an iron pin; thence S. 40-53 W. 100 feet to an iron pin; thence S. 47-29 W. 100 feet to an iron pin; thence S. 54-44 W. 100 feet to an iron pin; thence continuing with the southeast side of said Road S. 60-35 W. 30.2 feet to an iron pin, corner of property of Greenville Airport Commission; thence with the line of said property S. 15-23 W. 963.3 feet to an iron pin; thence continuing S. 9-53 W. 216.3 feet to an iron pin, corner of property of Sullivan Co.; thence with the line of said property and property of Griffin, Caine & Goldsmith, S. 52-41 W. 469.1 feet, more or less, to the rear line of tract on which grantor's aforementioned place of business is situate; thence along the rear line of said property S. 43-36 E. 682.8 feet to the beginning corner.

Office for Greenville County, S. C. in Deed Book 800, Page 621, and deed of Laurel Baptist Church, Inc., dated July 18, 1966, recorded in the R. M. C. Office for Greenville County, S. C. in Deed Book 802, Page 381, less the tract of approximately eight acres described on the above mentioned plat of Piedmont Engineers and Architects on which grantor's place of business is constructed and portions of the original tract which have been conveyed by the grantor to Laurel Baptist Church, Inc. and the County of Greenville.
