

SUBORDINATION OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS: That THE WESTERN AND SOUTHERN LIFE INSURANCE COMPANY, of Cincinnati, Ohio, does hereby subordinate the lien of its mortgage deed recorded in the RMC Office for Greenville County, South Carolina, in mortgage book 849, page 581, of the City of Greenville, South Carolina, to a right of way for the purpose of installation, alteration and repair of water lines over that portion of the real estate covered by said mortgage deed and more particularly described as follows, to-wit:

BEGINNING at a point on the Eastern side of Farm View Lane at a point at the Southern edge of existing 50 foot waterline right of way and running thence with the Southern edge of said right of way S 63-12 E 105 feet to a point in the Southern side lot line of the Thomas F. and Evelyn M. Goldsmith property; thence with said side lot line South 62 W 37.8 feet to a point; thence leaving said side lot line N 63-12 W 64.7 feet to a point on the Southern edge of Farm View Lane; thence with the eastern side of Farm View Lane N 5-30 W 35.5 feet to the point of beginning.

The land affected by this right of way is more particularly described and shown by deed to Thomas F. and Evelyn M. Goldsmith recorded in the RMC Office for Greenville County in Deed Book 692 at Page 520.

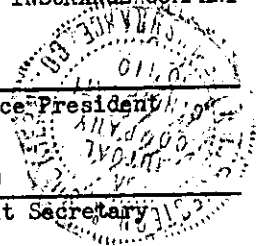

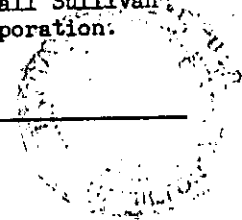
