All that parcel or tract of land in Glassy Mountain Township of Greenville County, South Carolina, lying on the west side of the Glassy Mountain Road, a highway leading from State Highway No. 101 near the Blue Ridge High School to State Highway No. 11 at the Glassy Mountain Baptist Church, bounded on the north by lands of R. Randolph Loftis and ~~xxxxxxx~~ on the east by said highway and lands of Dr. Joe M. Rogers and Lewis Gosnell, on the south and west by Arnold E. Emery and R.
