A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of

Three Thousand Seven Hundred Fifty and No/100 ---- (\$3,750.00) ----- Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto John D. Underwood, Jr. and Martha H. Underwood, their heirs and assigns:

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being shown and designated as Lot No. 15 on plat of Drexel Terrace, dated April 1, 1961, and prepared by Piedmont Engineering Service, recorded in the Office of the R.M.C. for Greenville County in Plat Book QQ at Page 177, and being more particularly described with reference to said plat as follows:

BEGINNING at a point on the easterly side of Dellrose Circle, joint front corner of Lots 15 and 16, and running thence along the common boundary of said lots, N. 67-54 W., 221.5 feet to a point at a branch line; thence turning and running along the said branch line, N. 51-28 E., 158.5 feet to a point, joint rear corner of Lots 14 and 15; thence turning and running along the common boundary of said lots, S. 47-57 E., 156.0 feet to a point on the easterly side of Dellrose Circle, joint front corner of Lots 14 & 15; thence turning and running along the easterly side of Dellrose Circle, S. 24-03 W., 85.0 feet to the point of beginning.

Said lot is subject to protective covenants for Drexel Terrace recorded on April 7, 1961, in the Office of the R.M.C. for Greenville County in Deed Book 671 at Page 355 and to building setback line as shown on said plat.

This is a portion of the property conveyed to the grantor herein by deed of W. B. Simmons, recorded on April 3, 1961, in the Office of the R.M.C. for Greenville County in Deed Book 671 at Page 155.
