ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, in Paris Township, being known and designated as Lot No. 109 & 110, as shown on Plat of Section 2, Bellwood Estates, dated 1955 by Woodward Engineering Co., recorded in the R.
