All that lot of land in Greenville County, State of South Carolina, on the northern side of Lakemont Drive near the City of Greenville, being shown as Lot 9 on a plat of LeRoy Tims, Jr., made by Woodward Engineering Company in July 1957, and further described as follows:

Beginning at a stake on the northern side of Lakemont Drive at the corner of Lot 8, and running thence with the line of said lot, N. 15-08 E. 176.7 feet to a stake in line of Elizabeth Heights; thence with the line of said property, S. 74-58 E. 80 feet to a stake on the western side of Lakemont Drive; thence with the western side of Lakemont Drive, S. 15-02 W. 152.7 feet to a stake at the corner of the right angle turn of Lakemont Drive; thence with the curve of the said turn, the chord of which is S. 60-26 W. 35.2 feet to a stake on the northern side of Lakemont Drive; thence with the northern side of said Drive, N. 74-10 W. 55 feet to the beginning corner.

This property is conveyed subject to the following restrictions:

1. No main dwelling shall be constructed on said property costing less than \$4,000.00.
2. Sewage disposal shall be by septic tank meeting the approval of the County Health Authorities.
