John J. Fisher

in the State aforesaid (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said **John J. Fisher:- All that certain tract of land in the State**

aforesaid lying partly in Spartanburg County and partly in Greenville County Beginning on a stone on Middle Tyger river and running thence S. 79 1/4 E. 6.40 to a stone on ditch thence N. 35 E. 5.10 with said ditch to bend thence N. Mulberry thence S. 85 1/2 E. 13.60 to a stone on old line, thence along said old line S. 24 1/2 W. 18.85 to a stone; thence S. 85 W. 3.00 to a stone thence S. 84 1/2 W. 12.40 to a pin; thence N. 78 W. 3.40 to a stone; thence N. 88 1/2 E. 2.27 to a water oak; thence N. 25 W. 68 links; thence N. 69 1/2 W. 2.50 to a poplar; thence N. 75 W. 9.80 to corner to river thence up the said river to the beginning corner, containing fifty four and one fourth (54 1/4) acres more or less, Being same tract conveyed to me by H.N. Fisher by deed recorded in Deed Book 4-G page 739. Also all that certain other tract of land in the State aforesaid and lying partly in Spartanburg County and partly in Greenville County Beginning on a stone in Tinsley Prewett's line and running S. 53 E. 3.98 to a post oak; thence S. 40 1/2 E. 2.78 to pine knot; thence 24 W. 9.75 to a stake or stone in line; thence N. 83 W. 15.00 to Mulberry thence S. 64 1/2 W. 11.47 to a Beech at Spring; thence S. 92 W. 2.80 to fork of ditch thence S. 37 1/2 W. 4.12 to a stone; thence N. 74 W. 5.25 to a stone on river; thence up said river to a W.O. thence S. 72 E. 10.90 to a small poplar and stone in field; thence N. 64 1/2 E. to the beginning corner containing twenty seven and one eighth (27 1/8) acres more or less and being the same tract conveyed to by Henry N. Fisher by deed recorded in Book 4-H, page 318 deeds to the above two tracts are recorded in the office of the R.M.C. for Spartanburg County, South Carolina in Deed Book 6-M, page 244.
