and partition of real estate, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) J. T. Farmer and his heirs and assigns forever:

All of that parcel or tract of land in Oneal Township of Greenville County, South Carolina, located about 7 miles north of the City of Greer, lying on a County road which leads southward from the Jordan Road, shown and designated as Tract No. 2 on a plat made for A. I. Farmer by Terry T. Dill, Surveyor, dated June 19, 1967, to be recorded herewith, and having the following courses and distances:

BEGINNING on an iron pin on the east side of the County road, the southwestern corner of the tract conveyed herein, and runs thence N. 14-03 E. 680 feet to an iron pin on the west side of said County road; thence the dividing line of Tracts Nos. 1 and 2, S. 71-23 E. 484.4 feet to an iron pin on the line of Tract No. 3; thence with the line of that tract, S. 16-18 E. 735 feet to an iron pin; thence N. 76-23 W. 853 feet to the beginning, containing 10 acres, more or less.

This is a portion of that property described in deed recorded in Volume 478, at page 67 in the R.M.C. Office for Greenville County. Myrtle H. Farmer died intestate on or about March 16, 1964, leaving as her sole heirs at law the grantors herein and the grantee.
