Howard filed in the R. M. C. Office for Greenville County in Plat Book J at page 61 and having, according to said plat and a more recent plat entitled "Property of Margaret G. Beginning at an iron pin on the eastern side of Loganberry Circle at the joint front corner of Lots 1 and 2 and running thence along Loganberry Circle N. 7-20 E. 71.8 feet to an iron pin; thence S. 82-40 E. 235.8 feet to an iron pin; thence S. 7-20 W. 71.8 feet to an iron pin at the joint rear corner of Lots 1 and 2; thence with the line of Lot 2 N. 82-40 W. 235.8 feet to an iron pin at the point of beginning; being the same property conveyed to the grantor herein by deed of Cornelia C. Balz and Evelyn H. Williams recorded in Deed Book 822 at page 276.
