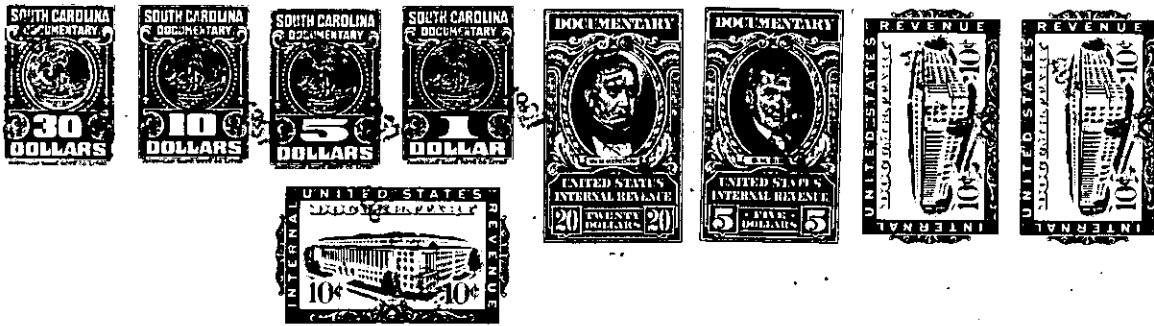
KNOW ALL MEN BY THESE PRESENTS, that Allen E. Vaughn and William A. Vaughn
